DECLARATION

No. RDA. 71/2015/SI, _____ . - Whereas, it appears to the Government that a total of 53.65 Bighas or, 71773.7 sqm. land is required in the village of Rongalgre under Rongalgre A.kingland from 16+300 Km. to 18+776 km, under East Garo Hills District for public purpose, namely, Acquisition of land for construction of 2-laning Shillong-Nongstoin Section of NH-44 and Nongstoin-Rongjeng- Tura Road State Road under Phase "A" ofSARDP – NE.
