Whereas it appears to the Government of Meghalaya that land measuring **29,202 Sq.M or 2.9202 Hectare** is required at certain locations in Ri-Bhoi District for Public purpose, viz **Additional Land for Slope Stabilization.**

Therefore, it is notified that for the above said Project Additional Land for Slope Stabilization land measuring more or less 29,202 Sq.M or 2.9202 Hectares whose detail description is given in Schedule to this Notification, is under acquisition.

This notification is made under the provision of Section 11(1) read along with Section 40 of the Right to Fair Compensation and Transparency in Land Acquisition Rehabilitation & Resettlement Act, 2013 (Act No.30/2013) to all whom it may concern.

The appropriate Government is pleased to authorize the Deputy Commissioner and his staff to enter upon and survey land take levels of any dig or bore into the sub-soil and do all other acts required for the proper execution of their work as provided and specified in Section-12 of the said Act.

Under Section 11(4) of the Act no person shall make any transaction or cause any transaction of land i.e., sale/purchase, specified in the Preliminary Notification create any encumbrances on such land from the date of publication of such Notification without prior approval of the District Collector.
