Whereas it appears to the Government of Meghalaya that a total of 10,891.32 Square Meters (8B-0K-14L) land is required in Silbaripara, South Garo Hills District, for setting up of Border Outpost for BSF under Silbaripara as provided in the Schedule of Boundary below:-

West : Patta Land.

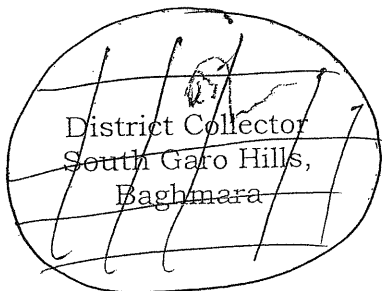
Therefore, it is notified that for the above said BOP in Silbaripara under South Garo Hills District, a piece of land measuring more or less 10,891.32 Square Meters (8B-0K-14L) whose detail description is given in Schedule to this notification, is under acquisition.


This notification is made under the provisions of section 11(1) read along with section-40 of The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act No. 30/2013), to all whom it may concern.

A plan of the land may be inspected in the office of the Deputy Commissioner, South Garo Hills District on any working day. The appropriate government is pleased to authorize the District Collector and his staff to enter upon and survey land, take levels of any land, dig or bore into the sub-soil & do all other acts required for the proper execution of their work as provided and specified in section 12 of the said Act.

Under Section 11(4) of the Act, no person shall make any transaction or cause any transaction of land i.e. sale/purchase, specified in the preliminary notification or create any encumbrances on such land from the date of publication of such notification without prior approval of the District Collector.

The notification is made under the provision of section 11(1) read along with section-40 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.

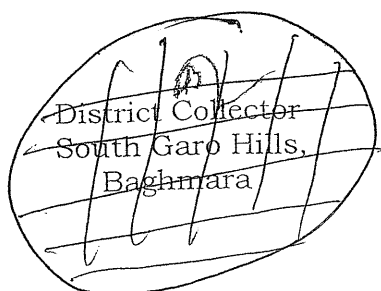
