Whereas it appears to the Government of Meghalaya that a total of **55318.58 Square Meters** is required in **Char Chapahati and Postischar 2 CD Areas** under South West Garo Hills, **Char Chapahati-1079 M.P to 1079-1S and Postischar 1080/2-T to 1080/2-S** for Indo-Bangladesh Border Fencing as per boundaries described in the statement attached.

Social Impact Assessment study was exempted by the Government under section 10A of the said act as amended by the ordinance, 2014 vide Govt. Notification No. RDA. 13/2015/64, Dated Shillong, the 18th March, 2015.


Therefore, it is notified that for the above said project in the above **2 CD Areas** of land under South West Garo Hills District a land measuring more than **55318.58 sq.m** whose detail description is given in the statement to this Notification, is under acquisition.

This Notification is made under the provisions of section 11 (1) of The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act No. 30/2013), to all whom it may concern.

A plan of the land may be inspected in the office of the District Collector, South West Garo Hills District on any working day. The appropriate government is pleased to authorize the District Collector and his staff to enter upon and survey land, take levels of any land, dig or bore into the sub-soil & do all other acts required for the proper execution of their work as provided and specified in section 12 of the said Act.

Under section 11(4) of the Act, no person shall make any transaction or cause any transaction of land i.e. sale/purchase, specified in the preliminary notification or create any encumbrances on such land from the date of publication of such notification without prior approval of the District Collector.

The objections to the acquisition, if any, may be filled by the person interested within 60 (sixty) days from the date of the publication as provided under section 15 of the said act before the District Collector, South West Garo Hills District.
