

Meghalaya a'dokko sason ka'gipana on'gimin kam jean songsul noksulni gimin sandie nion Gopinathkilla South West Garo Hills a'dokko jako rana gita janapaha jedakode BSF rangni dongimin Border Outpost ko Meghalaya-ni sorkarini jakko tangdoataniko dakna nanggen. A'ani nokgiparangara a'king nokma Shri. Rubison Areng, Shri. Gasin Sangma, Shri. C. Kerrassa Marak, Shri. Balsrang Areng, Smt. Sebanish Areng aro Shri. Mathew Marak ong'a. A'dok-ni gro gipengara 11412 square meters ba 2.819 acre ong'a.

Ia Project-ni miksonganide dongenggipa BSF/BOP ko sima ariko bariate gitalgipa Composite sima ariona tangdoatani ong'a. Ia gital gipa Composite sima sriko bariatanichi BSF-ni manderangna tangdobate, krabate aro jakkaltobate songdong a'chana miksongan ong'a. Ia a'ani gadangara a'bri aro akawe gnanggipa ong'a aro wilwilao songni manderang game ge'e chatokenga.

Skanggipao biapo nikeon game ge'e chana kragipa ong'a ine nikaha. Miksoggipa project ni biapo mamungba gea gamanirang aro mande nokrangba dongja. Project biapo Gopinathkilla BOP ko donmanaha jean jadok ba jasni mangna skangan abachengaha.

SIA sason kagipa jean a'dokko jako ra'ahachim, (uan Key Informant Interview) talaten onan baksa agangrikanirangko dakangaha. Key Informant Interview ko a:a nokgipa aro BSF-ni manderang baksa singa sananiko ongataha. Gopinathkilla-ni nokmako adita singanirangko dakaha aro 26 Battalion ni BSF Assistant Commandant baksaba Gopinathkilla-o agangrikaniko dakaha. Miksongan de projectni gimin uamangni chanchianiko aro wilwilao songna nokna mai a'sel onggen projectni gimin aganchina jedakode uno pangchake simsake biapo a'sel onggioniko ko komiatna namdapataniko dakna man'gen.

Ia project ko abachengna a'ako ra'anio mamingba namgijagipa a'selrang ongjawa ine nikaha. Arengh 26 BN BSF (SI)**, Gujangpara ni Nokma aro songni nokni manderangni mikango kadilaha. Gujangpara ni Nokma Pa. Rubison Arengh, indake janapaha ua a'a sakdok manderangni ong'a, uarangara Pa. Rubison Arengh, Pa. Gasin Sangma, Ma. Kerassa Marak, Pa. Balsrang Arengh, Ma. Sebanish Arengh aro Pa. Mathew Marak ong'a. Pa. Rubison agandapaha, BOP Gujangparao donganichi dao dipete maming cha'uani, sruksruk palatani, matchu cha'uani dakgiparang ua songo dongkujaenga. Pa. Rubison project ni giminba kusi ong'a aro antangni namnikaniko parakjolaha, uamang a'ako BOP rikna on'anio neng'nikani dongja ine janapaha. Bonkame Public Hearing-o Sorkari-ni a'a bre'e BOP ko rikna manchisoanio darangba jegalani dongja.

Skanggipa Bak (i): Talatchengani

Notification letter no. RDA.15/2017/29 dated Shillong, the 30th May, 2017 –o pangchake Border Outpost ko Gopinathkilla South West Garo Hills District ko dalbate a'a radapani bidingo Social Impact Assessment ko ba am'sandiani kamko kana gita MIG donataha. Ia BSF ni BOP ko daldapataniara wilwilao song nok ni manderangna aro a'a nokgipa rangna ongbagni namgni ba nengnikani pilakko am'sandie sandichimongani ong'a.

Department of Border Management-ko Ministry of Home Affairsni ning'a'o 2004 ni January-o a'bachengataha aro uni miksonganiara a'song ni a'a aro sima arirango donggipa a'arangko simsake rakkina aro Border Area Development Programme-ni kam rangko ka'na aro sima arirangko tik dake donani ong'a. Border Management-ni Department sima ariko naljokke rakkina gita aro a'songni sima ario nanga rikanirangko rikna gita bang'a kamrangko a'bachengataha. Sima arirangko name nirokanian mongsongbatgipa a'songni nama chelchakani ong'a.

Nengnikanirangko talatani

India aro Bangladesh ro'gipa International sima ari ong'a aro uni roara 4,156 km (2,582 mile) donga aro ian a'gilsak gimiko bongagipa ro'batsranggipa ong'a aro uni gisepo Meghalaya State-ni manpagipa sima 443 km (275 miles) donga. Indo Bangladesh sima ario niam gri ariko napbadrakani kamrang aro niam gri Bangladesh-oni India-oni katbaniko rake nisandie nianian dalgipa ra'biani ong'a. Ua biapo manderang namen jelbra jelsua aro bang'a gama ge'anirangkoba manderang daktoka.

India a'songni sima ariko nirokgiparangni mongsongbatgipa nengnikanirangara: Sima ari batsotdrae kenatanirang, napsrukdraanirang silchidare rabbitgiparangni sriksrik sima ari batanganirang, pekgipa samrang aro silchi dare srik srik palanirang, niam gri katnapbae

donganirang etc. A'songni sima ariko nirokanina dingtangmancha dongimin aro bil ongimin ara Department of Border Management ong.a. Ia department jean ministry of Home Affairs ni ningao ong'a, dingtangmancha pilak International land (a'songni a'mal aro sima) aro coastal border ko nirok simsakna kam dongimin rangara nambate simsak champengna gita rama jalangko tariani, pakma diwalirangko pilak a'mal sima rango riktapani aro mangrakatani, walni somoirango aro tengbatsranggipa light aro current rangko tariani uandake sal aro walrango simsak champengsoani ong'a.

Border Outpost (BOP)-ara BSF rangni mangsonggipa kam kachakani biap ong'a aro un baksana a'songni International sima ario ong'a obostarangko nirikna kam kana gita, greprak BOP na dingtangmancha pakwat uiatgimin biapko nirokna bilko onaha.

BOP rangara sima ariko batange niam ko pegipa manderangko bilchi champenani, aro sima- ariko bade'e napdragiparangko, a'songni chelchakanina kamko ka'a. India aro Bangladesh a'mal simina joljol gimikchi dam 1,011 border outpost rang gnang aro uarangko simsak champengsona gita ge 82 BSF battalion rangko donataha. Tosuasie nigenchimode Indo-Bangladesh Border-ni ningao BOP gesaoni gesaona chelgrikaniara Indo-Pak- ni BOP gesaoni gesaona enggrikanira chelbata. Indo-Pak-ni BOP gegni gisepo chelgrikaniara 4-5 km ong'a indiba Indo-Bangladesh Borderni BOP gegni gisepo chelgrikaniara 15-20 km donga. BOP rangni gisepo chelgrianiko 3.5km ona tangon komiatna miksonganini ong'a. Ia miksonganiko chusokatna gita dingtang mancha India sorkari 2009 bilsio dam 509 BOP ko rikdap songdapaniko tik ka'aha. Indiba 2016 bilsio iako dam 422 ko tik kaskaha. BOP rangni gisepo chelgrianiko 3.5km ona komiatani a'songko nirokani aro Border-o ongenggipa kamrangna nangchongmotgipa ong'a. Uandake India aro Bangladesh a'mal sima jolni songrango, manderangni jelbrajelsuaniko 2004 bilsio toe niani git agro gipeng sq. Km prakko sak 181 manderang gnang. Kari bilsini dingtangroroanichi aro chibima chi bana redap ongdapanichi

aro uni kosako manderangni jelbrajelsuanichi dingtangmancha nengnikanirang bangbatrorobaenga. Aro ukon dingtangmancha “Climate Refugee” ineba agana.

Iana, dongimin BOP ko “composite BOP” ona tangdoataniko chanchie oprake onnaniko ra:gataha. A:songo dongenggipa 1901 BOP rangoni jekon BSF rang nirokenga, 422 de composite BOP-ni gadang ong:a indiba dongrikenggipa BOP rangde onkalgipa gadangsan ongaia. Composite BOP ni gadang ine masion dongdongmotna nanggiparangara sipai jawan rangna dongchak tuchakna gita barrack nok dongna nanga ba babilsi nok dongna nanga, mi chachakram biap dongna nangna, gari dongchakani biap, generator na kuturi, kaldik ba kichak subuchakani nok, office kachakani administrative nok, wireless kuturi, silchidareko donchakram kuturi aro guli bom rangoni naljokna gita cement aro iron rod ni rikgimin nok ba bunker nok komigija gedok mang, aro mata biarangko altuae sana ban gita sampat aro biap rangko nangchongmota. Ia indakgipa gadangni BOP rangara, nambate nirokanio pangchake aronambatgipa nanganirangko BSF rangna ona jedakode uamng Border ko nianio nambate dakchakgen. Agangimin Gopinathkilla BOP ni sepango gegipin Gujangpara BOP Boundary Pillar (BP)1090 oni.

Ia biap-ara South West Garo Hills District ni Betasing block-o ong'a aro Indo-Bangladesh Border-ni ning'tugipa biapo ong'a. Ia project ni biap Gopinathkilla BOP, Gujangpara songoni 6 kms rangni gita aro Rithingpara BOP oni 8 kms rangni gita ong'a.

Indo-Bangladesh sima ari a'bri, chirikam aro a:palarigipa a:a ine agana gita mangen. Meghalaya bak-o donggipa Indo-Bangladesh-ko bak gittam dake bak ka'na mangen. Ia Indo-Bangladesh sima ariko 2016 ni bilsio a:song niam ko jarike zero point-oni 150 yards chele border fencing ba ari kaaniko dakaha. Ia biapko a'bri rara gipa biap ine agana mangen. Ia a'bri-ara a:sal gnanggipa ong'a aro uno chonchongipa bol wa:arang donga. Ia Gopinathkilla BOP-oni Gujangpara BOP-oni nangdimegipa rama jeon BSF Battalion dongachim ua sorokara pakka (Black Topped) ong'a. Rama aditan namgenchimoba naptapatna gita mangen.

Ia biapo songdong a:chagipa dongja aro ia project-ni sepangjolrango game ge'e chana gita mangen, uni gimin project site ni gimin mamung nengnikani dongjawa. Ia songrangara Gopinathkilla BOP-ni 1km oni 3 km ni gita chelgrika.
