Ka Jingbatai Lyngkot

Ka East Jaintia Hills District jong ka Meghalaya ka don ha ka thain mihngi jong ka jylla. Ka nongbah jong kane ka district ka dei ka Khliehriat. Ka jinggeh jong kane ka district ka long 2115 km². Kane ka district ka don ar tylli ki Community bad Rural Development Block bad kita ki long ka Khliehriat Community bad Rural Development Block bad ka SaipungCommunity bad Rural Development Block. La ker sawdong ia kane ka district sha ka thain shatei da ka jylla Assam bad ka West Jantia Hills District; sha ka thain shathie da ka ri Bangladesh bad ka jylla Assam; sha ka thain mihngi da ka jylla Assam bad sha ka thain sepngi da ka West Jantia Hills District. Ka East Jaintia Hills ka don 1,22,436 ngut ki briel bad ka jingnang jingstad napdeng kine, kat kum ka jingniew ka ba 2011 (Census 2011) ka long 53 na ka shispah. Kiba bun ki nongshonghnong jong kane ka district ki long kiba wan na ki longiing kiba duk, wat lada ki don ki katto katne ki longiing kiba don ba em haba ia nujor bad u ‘Poverty Line’(u lain uba pyniapher hapdeng kiba riewspah bad kiba duk), namar ka jingdon jong ka spah khhyndew kum u dewiong bad u mawshun bad ki jingthung kiba pher bapher. Ki briel ha kane ka district ki kren ia ka ktien ‘Pnar’ bad u khaw u long u jingthung uba la rep kham bun. Nalor u khaw, ki briel jong kane ka district ki rep ruh ia u kwai, u tympew, u phan, u phandieng, u riewhadem, u shynrai, u sying, u sohmarit bad kiwei kiwei. Kane ka district ka dap kyrhai da u mawshun bad ka dei kane ka jingdon jong u mawshun kaba la khring ia ki 10 tylli ki kompeni pynmih dewbilat sha kane ka jaka.

Ka shnong Mualhoi ka don ha ka Saipung Block jong ka East Jaintia Hills District, Meghalaya bad ka jngai kumba 67 km. shaphang mihngi na ka nongbah Khliehriat bad 148 km. na ka nongbah jong ka jylla-ka Shillong. Kane ka jaka ia kaba la thmu ban thied da ka sorkar ban thung dieng kylliang na ka bynta ki jaka khlaw ba thmu banpom dieng na ka bynta ban tih mawshun, ka don ha Pat Khui Mual ha Mualhoi bad ka jinggeh kane ka jaka ka long kumba 154.888 hectares. Kane ka jaka ka jngai kumba 3.491 km. na ka iingmane kaba don ha Mualhoi bad la ker sawdong ia ka da ka Wah Khynriam sha ka liang mihngi, ka Fiang Inren sha ka liang sepngi, ka Pat Khui Dung sha ka liang shatei bad ka Lung Par sha ka liang shathie. Shwa ban thied ia kane ka jaka kaba ha Mualhoi, hajan ka Saipung Reserved Forest, la ai ha ka State Institute of Rural Development (SIRD), Meghalaya ban pyniaid ia ka jing jari ban ioh jingshai haduh katno, kane ka jingthied ia kane ka jaka kan ktah ia ka imlang ka sahlang. Ka M/s Adhunik CementLimited, kaba dei ka kompeni pynmih dewbilat kaba la pan jingbit na ka sorkar ban pyndonkam ia ki khlaw ha Thangskai ban tih mawshun, ka la kdew ba kane ka jaka ka long kaba biang ban thung dieng markyliang na ka bynta kitei ki khlaw kiba thmu ban pom. Kane ka jaka kaba don ha ka shnong Mualhoi, ka long ka jong u Bah Phon Syih bad lada ka jingthied ia kane ka jaka na ka bynta kane ka phang kam wanrah ia ka jingsniew ha ka imlang sahlang, yn shim ia ka da ka sorkar ban bat da ka Forests & Environment Department, na ka bynta ban thung

dieng, kat kum ka jingdonkam jong ka Forest (Conservation) Act, 1980. Ban pyniaid ia kane ka jing jari, ka SIRD ka la rai ban pyndon kam da ki rukom lum jingtih halor ki longiing kiba lah ba shah ktah da kane ka jingthied ia kane ka jaka bad kumno kane ka jingthied jong kane ka jaka kan ktah ia ka

imlang-sahlang jong ki. La lum hiiia ka jingwad tynrai da ka SIRD bad ka da pyndonkam ruh ia ki jingthoh halor ka imlang sahlang ha kane ka jaka. La ai ruh ia ki nongshongshnong ha kane ka jaka ia ki jingkylli ban ai jubab. Kine ki jingkylli ki long halor ki mat kiba iadei bad ka imlang sahlang jong ki briew ha kane ka jaka. La don ruh ka ‘public hearing’ ne ka jingialang paidbah ban pynhai halor kane ka jingthmu ban thied ia kane ka jaka da ka sorkar bad ki jingkylli bad jingmudui lada don kino kino halor jong ka, khnang ban ioh jingtih halor ki iing ki sem kiba shah ktah da kane ka jingthied, bad ban wad ruh lada don kano kano ka jingktah kaba sniew ia ka imlang ka sahlang namar kane ka jingthied, ha kane ka jaka.

Kane ka jaka, kumba la kdew haneng, ka dei ka jaka jong U Bah Phon Syih, uba long u trai khyndew, ia kaba yn aiti ha ka Forests & Environment Department da ka sorkar, kat kum ki kyndon jong ka Ministry of Environment, Forests & Climate Change, shwa ban ai jingbit ia kane ka kompeni pynmih dewbilat, ka M/sAdhunik Cement Limited, ban tih mawshun ha ki khlaw ha Thangskai. Ia kaba mynta, kane ka jaka ka long ka jaka kaba ym lah ban rep bad na kaba tang katto katne ki briew, ki lum phlang ban shna tnum iing ha ki iing jong ki.

Ka shnong Mualhoi ka don 47 tylli ki longiing bad ka jingdon jong ki briew ha kane ka jaka ka long 288 ngut. Ki don ki skul (primary, upper primary bad middle school) ha kane ka shnong. Ka skul bah (secondary school) ka don ha kawei pat ka shnong kaba kyrting ka Mualsoi. Ka jaka ieng bos ka don ha Lung Mai Cham had ka steshon rel ka don ha Haflong kaba don ha ka jylla Assam. Ka skul (Higher Secondary / +2), ka Primary Health Centre (ka jaka sumar ia ki nongpang), ka Kisan Seva Kendra Bank (ka lad ai jingiarap ia ki nongrep), ka Common Service Centre (ka jaka ba ai ia kiwei pat ki jingiarap kiba pher ba pher), ka Veterinary Care Centre (ka jaka ba ai jingsumar ia ki mrad) bad ka Post Office (ka iing dak) ki don ha Saipung bad ka Milk Co-operative / Collection Centre (ka jaka lum bad die ia ka dud), ka Community Health Centre (ka jaka sumar ia ki nongpang) badka kor na kaba lah ban shim pisa (ATM) ki don ha Sutnga (Cement). Ka Health Sub-Centre (ka jaka sumar ia ki nongpang) ka don ha Thuruk bad ka jaka pule ITI / Polytechnic (ITI / Polytechnic Centre), ka Agro Service Centre (ka jaka ba ai jingiarap ha ki kam thung jingthung), ka jaka buh ia ki kot ban pule ki paidbah (Library), ka Ayurveda Centre (ka jaka ba ai ia ki jingmyntoi ba ioh na ka Ayurveda) bad ka E-Seva Kendra (ka jaka ba ai jingiarap ha ki kam kiba pyntrei lyngba ki kor komputor) ki don ha Jowai.

Ka shnong Mualhoi kam don ki surok kiba paka ban pyniasoh ia ka bad kiwei pat ki jaka, lane ka rukom sam um-bam um-dih ba paka, ka rukon bret niut ka ban ym pynjulor ia ka mariang, ka

bording elektrik, ki jaka ialehkai na ka bynta ki khynnah bad ka rukom sam ia ki marbam mardih kaba paka (PDS). Ki nongshongshnong jong kane ka shnong ki pyndonkam ia ka jaka na ka bynta ban rep, ban ai um sha ki jaka rep bad ban thung ia ki dieng bad kiwei pat ki jingthung. 47 tylli ki longiing ki don ia ki syrnod bylla(job card) jong ka MGNREGA bad tang 7 tylli ki longing kim shym la ioh ia kine ki syrnod, kat kum ka SECC 2011.Ym don ki Kynhun Iarap Ialade ha kane ka shnong bad ym don ruh nongtrei sngewbhana ka bynta ka Bharat Nirman ha kane ka shnong.

Kiba bun na kine ki longing ki long ki longing ha kiba u khlieh ka iing u long u kpa jong ka iing bad kiba bun ki longiing ki don kumba 6 ngut ki dkhot jong ka iing. Kiba bun na ki biew jong kane ka shnong ki long kiba la rangbah, bad ha ka jingbun paid, la bud ia kida ki khynnah bad khynnah samla kiba hapdeng 6-18 snem ka rta. Ki don ruh tang khyndiat ki khynnah kiba hapoh 6 snem karta. Ha kawei kawei ka longiing, don kumba 3.1 ngut ki biew na ka 6kiba lah tam ia ka 18 snem ka rta, 2.8 ngut ki biew na ka 6kiba don hapdeng 6 bad 18 snem karta bad 1.5 ngut na ka 6ki khynnah kiba hapoh 6 snem ka rta.

Kiba bun ki khynnah ki la ioh ki dawai injek kiba pher bapher ban iada ia kina ki jingpang tangba tang khyndiat na ki, ki la ioh ia ki dawai ban pynduh ia u wieh ha ka kpoh. Kiba bun na ki nongshongshnong ki sait ia ki kti jong kida ka sabon hadien ba ki lah wan na ka painkhana bad shwa ban bam. La shem baym shym la bun ki briel kiba don la ki iing ki sem ne ki jaka hajan kane ka jaka u Bah Phon Syih bad ka jingthied duh ia ka jaka jong u da ka sorkar kan ym don ka jingktah kaba sniew ia ki, ne kanpynduh ia ki hok tynrai jong ki namar kim pyndonkam ia kane ka jaka na ka bynta ban rep ne ban pyndonkam ha kiwei pat ki rukom na ka bynta ban ioh kamai ja kpoh. Baroh ki nongshong shnong ki tip shaphang kane ka jingthmu ban shim noh ia kane ka jaka U Bah Phon Syih da ka sorkar.Ki sngewthuh ruh ka mut aiu lada ia kane ka jaka yn shim noh da ka sorkar bad baroh ki ia mynjur ia ka jingthmu jong ka sorkar, khnang bayn ioh thung dieng ha kane ka jaka, ban pynmih kyliang ia ka khlaw kaba yn pom ha Thangskai da ka kompeni M/s Adhunik Cement Limited na ka bynta ban tih mawshun. La pyntip bad pynsngewthuh ia ki halor kane ka phang da u rangbah shnong, ka dorbar shnong bad ki nongtrei sorkar. Ki pdiang sngewbha ia kane ka jingthmu jong ka sorkar namar ki kyrmen ba kan wan rah ia ka jingroi ha shnong bad ba kan plie ia ki lad ban ai kamai ia ki nongshong shnong.

Ka Khliehriat, ka kylla long ka Administrative Unit ha ka 14 tarik u Nailar, 1976 bad ka Civil Sub-Division ha ka 27 tarik u Jymmang 1982 shwa ba kan kylla long ka nongbah jong ka district East Jaintia Hills. Ka East Jaintia Hills district ka don kumba 1200 m. kynjang na sla duriaw bad ka shong hapdeng u 25° 17' 30"bad 25° 22' 40"u phuid thiah (latitude) bad hapdeng u 92° 15' 20"bad 92° 23' 30"u phuid ieng (longitude).Kane ka district ka don ar tylli ki Community bad Rural Development Block bad kita ki long ka Khliehriat Community bad Rural Development Block bad ka Saipung Community bad Rural Development Block. 






