Lynnong 1: Ka Lamphrang

1.1 Ka ‘tien khmat

Ka Central Board of Excise and Customs (CBEC) kadei shi bynta na ka tnad jong ka Revenue hapoh ka Ministry of Finance, jong ka Sorkar India. Ka trei ia ki kam ha kaba iadei bad ka jingthaw ia ki ain ki kanun(formulation of policy) halor ka rukom siew bad lum khajna hapoh ka Customs bad Central Excise, kumjuh ruh halor ka jingiada na ki kam khaii tuh bad halor ka jingpeit ia ki kam kiba iadei bad ka ophis Customs, Central Excise bad Narcotics katkum ka jingpyniaid jong ka CBEC. Kane ka Board kadei ka nongpeit bad nongpyniaid ia ki tnad treikam ba kham hapoh kaba kynthup ia ka Custom Houses, Central Excise and Service Tax Commissionerates bad ka Central Revenues Control Laboratory.

La seng ia ka Shillong Customs bad Central Excise Collectorate¹ ha ka 1 tarik u Iaiong 1947 ha ryngkat bad u Collector na Calcutta uba bat-kam kum u Collectorate. Hynrei hadien ka jingthung ia u Collector ha u bnai Lber jong u snem 1951, lah sdang ban pyniaid noh ia ki kam da u Collectorate ba pura uba dei peit bad synshar ia baroh ka thain shatei lam mih ngi jong ka Ri India (North East India). U Collectorate u lah peit bad synshar ia baroh ki kam ha kaba iadei bad ka Customs ophis bad Central Excise haduh ba lah phiah noh ia ki ha u snem 1993 ha kaba la thung noh la u jong u Customs (Preventive) Commissionerate ha ka jaka u Collectorate (Commissionerate). Hadien kane, ha u Nohprah jong u snem 2002, ynda lah pynwandur biang ia ki nongtrei ha kane ka tnad treikam, la seng ia ka Chief Commissionerate of Central Excise & Customs ba la khlieh da u Chief Commissioner uba long ruh u nong peit bad nongpyniaid kam halor ka jingpynwandur ia ka Shillong Central Excise Commissionerate, Dibrugarh Central Excise Commissionerate, Guwahati Central Excise Commissionerate, Customs Commissionerate (Preventive), North Eastern Region, Shillong bad Commissionerate of Central Excise (Appeals), Guwahati.

Ka Commissionerate jong ka Customs (Preventive) Shillong² ka don ka bor synshar ha baroh hynniew tylli ki jylla jong ka thain shatei lam mih ngi (North Eastern Region), kita ki long ki jylla Assam, Arunachal Pradesh, Manipur, Meghalaya, Mizoram, Nagaland bad Tripura.

Kane ka thain ka don kumba 2.55 lakh sq. km ka sawdong sawkun. U commissionerate u don ka bor synshar ha baroh ki thain shatei lam mih ngi (North Eastern Region) kaba kynthup ruh ia 1640 km ka jaka khappud jong ka Indo-Myanmar, 1500 km ka jaka khappud jong ka Indo-Bangladesh, 1000 km ka jaka khappud ha Indo-China bad kumba 1100 km ka jaka khappud jong ka Indo-Bhutan.

Ia ka kam jong ka Commissionerate lah phiah haduh phra bynta (8 divisions) kaba don haduh 25 tylli (arphew san) ki Land Customs Stations ha ka khappud Indo-Bangladesh, 3 (lai) tylli ki Land Customs Stations ha ka khappud Indo-Myanmar bad 3 tylli ki Land Customs Stations ha khappud Indo-Bhutan. Nalor kane ka Land Customs Stations, ka don ruh kawei ka Inland Container Depot ha Amingaon, Guwahati bad ka kad liengsun baheh (ka Lokapriya Gopinath Bordoloi International Airport) kaba don ha Guwahati, Assam. Kane ka airport ka lah paw hapoh ka International air traffic map hadien ka jingsdang ban pynher ia ka liengsuin(Air India Flight) na Guwahati sha Bangkok ha ka 4 tarik u Iaiong 2002.

Ban ialeh pyrshah ia ki jingkhahi tuh ha kane ka thain, ka Commissionerate ka lah buh kawei ka Headquarters Preventive Unit, 8 (phra) tylli ki Divisional Preventive Units kiba don ryngkat bad ki tnad bapher bapher, 28 (arpher phra) tylli ki Customs Preventive Forces (CPF) bad 16 (khad hynriew) tylli ki Preventive Posts (PP).

1.2 Ka thymmei jong ka projek

Ka Shillong Custom Division ka don ar bynta bad kita ki long: ka Land Customs Station bad ka Preventive Formation. Kine ki Land Customs Station ki long ka Bholaganj LCS, Borsora LCS, Dawki LCS, Shella Bazaar LCS, Balat LCS (ka bym treikam shuh), Rynghu LCS (ka

bym treikam shuh). Ki Preventive formation ki long ka Anti-Smuggling Unit ha Shillong; Pynursla Custom CPF; Umkiang CPF bad ka Ichamati PP.

Ia ka ophis customs kaba don ha Borsora lah shem ha u snem 1973 bad ka lah sdang ban treikam ha u snem 1993. Ka Borsora LCS ka dei peit ia baroh ki thain kiba don naduh ka shnong Mawpyllun shaduh ka shnong Ganga nagar. Kane ka station ka peit khambniah ia ka rukom shalan ia ki mar kum u dewiong bad mawshun sha ri Bangladesh. Ki lah pyndie lilam ruh ia ki mar-pyut kiba lah shah bat noh ha ki shipai Border Security Forces (BSF). Ka don baroh 11 ngut ki nongtrei; 7 ngut ki ophisar bad 4 ngut ki nongtrei sngi. Haduh mynta, ka ophis custom kaba don ha Borsora ka don ka jaka treikam kaba shu shim wai.

1.3 Ka jingbatai bniah shaphang ka projek

Ka Ministry of Finance (Department of Revenue) kaba don hapoh ka Superintendent jong ka Custom ophis ha Borsora, ka lah thmu ban shim ia ka jaka kaba pyndonkam haduh mynta da ka Borsora LCS na ka bynta ban tei ia ka ophis Custom ha Borsora kaba yn pyntrei da ka Sorkar Meghalaya bad kaba don ka jaka kaba heh haduh 347.035Sq.m hapoh Ranikor C&RD blok, South West Khasi Hills distrik, Mawkyrwat.

1.4 Jingdonkam ban shim ia kane ka jaka

Na ka jingjuripbniah, lah ban kdew hangne ba ka Custom ophis kaba don ha Borsora ka long kaba i sangsot ban peit bad ka dei ka iing kaba shu shim wai. Kane ka iing kam pat biang satia ban shong ban sah ki ophisar bad ki nongtrei; kam don ka jaka treikam kaba biang; kam don ka jaka buh ia ki kot ki sla bad ki file; kam don ka sem ban buh ia ki mar pyut bad ia ki mar bym pyut; kam biang ka bording; kam don ka Information Communication Technology(ICT) kaba biang; kam don ka kynroh kaba skhem; kam don ki nala ba biang; kam don ka jaka shong thait bad kam don ka guest house ia ki ophisar kiba wan sah ne wan donkam. Lah iohi ba ha ka por slap, kane ka ophis ka lah dap lah shlei da ka um slap. Ka jingdon jong kane ka ophis Custom ha Borsora hajan ka Zero point (Indo-Bangladesh Border) ka pyni ba ka long kaba donkam ban shim ia kane ka jaka.

1.5 Ki jingthmu bad jingdonkam jong kane ka projek

Ka jingthmu ba kongsan jong kane ka projek ka long ban tei ia ka Custom ophis ha Borsora kaba skhem bad ba iaineh ka ban wanrah ia ki jingdonkam kiba biang ha kane ka Custom ophis kaba don mynta ha Borsora.

1.6 Ka jaka jong ka Projek

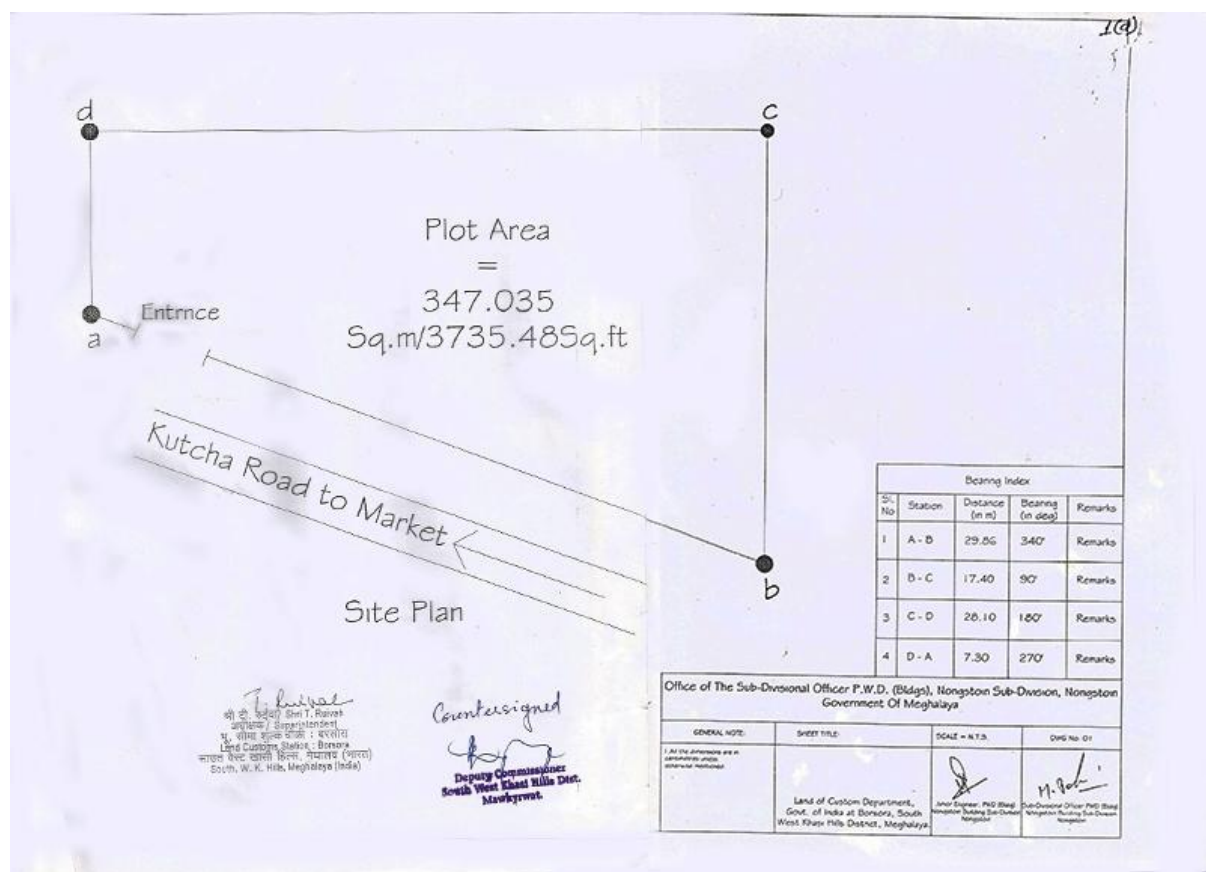
Ka ophis customs kaba don ha Borsora ka jngai duna ia ka 500meter na ka Zero point. Ia ka ophis Custom kaba don ha ka jaka ba long iew ha Borsora la ker sawdong da ka lynti ia idkijat bad ka surok khyndew kaba leit sha kane ka iew, da ki iing maw, bad da ka nala rit ne wah duid.

1.7 Ka jinglong trai ia kane ka jaka ba thmu ban shim

Kane ka jaka ba thmu ban shim ka hap hapoh ka bor synshar jong ka *Hima Langrin Syiemship*.

1.8 Ka map kaba pyni ia ka jaka jong ka projek

Kane harum ka long ka map kaba pyni ia ka jaka ba thmu ban shim.



Lynnong 2: Ki Lad bad Rukom Wadbniah

Ka rukom wadbniah kaba ki kynhun SIA ki pyndonkam ka long kaba sani bha. Kane ka rukom wad bniah ka batai thik ia ka jingshisha ha kaba iadei bad ka jinglong jingman jong ki briew ne khyndew ne kiwei kiwei. Kane ka jingwadbniah ka kynthup naduh ka jinglum ia ki jingtip kiba batai shai shaphang kiei kiei kiba iadei bad kane ka kam, bud pat da ka jinglum jingialang, ka jingpynbeit ia ki jingtip,ka jingpyni ia ki jingthoh jingtar bad ka jingbatai shaphang ki jingtip ba la ioh lum.

2.1. Ki Jingtip nyngkong eh na ki nongshong Shnong

Ka kynhun wadbniah ka la kylli jingkylli ia u Ophisar na ka Land Custom Station kaba don ha Borsora, Ranikor; ki nongsynshar shnong- *syiem* jong ka *Hima Langrin* bad Rangbah Shnong jong ka Borsora. Ki lad bad rukom wadbniah kiba lah pyndonkam hangne ki long kiba la thaw ha kata ka rukom khnang ban sngewthuh shai halor ka jingktah jong ka projek. Ha ka por ba leit jurip bniah ia ka jaka, kine harum ki long ki lad ki rukom ba lah pyndonkam ban lum ia ki jingtip:

Nyngkong eh la leit jurip bniah ia kane ka jaka lyngba ka jingpyndonkam da ka Scoping checklist. Kane ka kynthup ia ka jingwad bniah halor ki jingktah kiba lah ban mih lyngba ka jingpyntrei ia kane ka projek kiba donkam ban peitbniah bad kumjuh ruh ban batai shai halor ki lad ki lynti ki ban sa shim na ka bynta ban pyndep ia ka jingthmu ba nyngkong eh halor kane ka jingshim jaka. Kane ka jingjurip bniah ka la iarap shibun ban pynbha ia ki Terms of Reference (TOR) na ka bynta ka jingbisharbniah bad pynshongdor ia ki jingktah ha ka imlang sahlang lane ka Social Impact Asessment.

Ka Jingphylliew Jingmut bad ki briew kiba don bynta ha kane ka projek

Ka jingtreikam ba bha ka donkam ia ka jingsyllok ba don shibun ki nongiashim bynta kiba dei ki nongshong Shnong ki ban shah ktah bad kiwei kiwei ki kynhun ki ban shah ktah. Ka jingiakylli jingkylli markhmat bad ki briew ba kham tip bha halor kane (Key Informant Interview) la pynlong bad ki trai jaka, ki nongsynshar Shnong kiba don bynta ha kane ka jingshim jaka. La pynlong ruh ia ka jingpynsngew paidbah ban iasylllok bad ki nongshong Shnong. Ka jingthmu jong kane ka long ban ai lad ia ki nongshongshnong ba kin pynpaw ia la ka jingsngew halor kane ka projek bad halor ki jingktah jong ka, khnang ban shim khia ia ki katba dang thaw ia ki lad jingiarap halor kine ki jingeh.

2.2. Ka jinglum jingtip na ki kot ki sla

Nyngkong eh ka kynhun wadbniah ka pule bad wadbniah bha ha kaba iadei bad ki kot ki sla ban sngewthuh shai halor ki jingdonkam jong kane ka jaka na ka bynta ka projek. Da kaba pynshong nongrim ia kine ki jingthoh, ka kynhun wadbniah ka la lah ban ngam jylliew halor ka thymmei jong ka projek bad na kine la lah ban lum ia ki kynhun ba don bynta ha kane ka projek bad kumjuh ruh ban thaw ia ki jingkylli. Ki jingtip ba lah ioh na ki kot kum ka jingbatai shai halor ka Projek, ki jingkhein jingdiah, ki map bad ki jingbatai shai ia ki trai jaka lah ioh na ka Revenue and Disaster Management department, jong ka Sorkar Meghalaya, Shillong.

2.3. Jingpynsngew Paidbah

La pynlong ia ka Jingpynsngew paidbah na ka bynta ki briew baroh kiba don bynta ha kane ka Projek; ha kaba la sam ia ka kaiphod lyngkot halor kane ka projek bad la ai jingpynshai halor kino kino ki jingkylli. Ka Jingpynsngew paidbah ka long kawei na ki lad jingkylli lyngba ka Jingiakynduhlang ba lah mang lypa(formal meeting) khnang ban ioh ia ka jingsakhi lang jong ki paidbah/ ki briew ba don bynta ha kane ka jingthmu ban shim jaka ban tei ia ka Custom ophis ha Borsora, South West Khasi Hills Distrik.

2.4. Ka Jingpyniakhlad bad Pynbeit Ryntih ia ki Jingtip

Ia ki jingtip ba la ioh lum ha ka por ba leit jurip la pynbeit bad pyniakhlad bha ha ka rukom kaba dei.

Lynnong 3: Jinglong jingman bad Sawdong Sawkun jong ka Shnong

Ka jaka ba thmu ban tei ia ka Land Custom Station ha Borsora ka hap hapoh ka jingpeit jong ka Ranikor C&RD block, South West Khasi Hills Distrik, Mawkyrwat. Ka shnong Borsora ka don kumba 15 km na Ranikor C&RD Block. Ha kane ka bynta yn pynpaw ia ki jingktah(kiba sniew ne bha) kiba mih na kane ka jingtei bad kumjuh ruh ia ki jingdonkam kiba don mynta ha Borsora.

3.1 Ka Jingbatai lyngkot ia ka South West Khasi Hills Distrik

La oh dur ia ka South West Khasi Hills distrik na ka West Khasi Hills distrik ha ka 3 tarik u Nailar 2012. Ka district headquarters ka don ha Mawkyrwat. Kane ka distrik ka don ka sawdong sawkun haduh 1,341 km². Ka distrik ka kynthup ia baroh ki shnong kiba don ha ar tylli ki Blok kata- ha Ranikor bad ha Mawkyrwat Community & Rural Development Block.

3.2 Ka shnong Borsora

Ka shnong Borsora³ ka don ha Ranikor Blok ha South West Khasi Hills distrik, Meghalaya bad ka don haduh 76 tylli ki longiing. Ka shnong Borsora ka don haduh 482 ngut ki nongshong shnong ha kaba 273 ngut kidei ki shynrang bad 209 ngut kidei ki kynthei katkum ka kot khanasamari jong u snem 2011.

Ha ka shnong Borsora, ki khynnah hapdeng ka rta 0-6 snem ki don haduh 77 ngut kaba kot haduh 15.98% na baroh ka jingbun briew ha kane ka shnong. Ka jingnujor ia ka jingdon ki kynthei shynrang ha ka shnong Borsora ka long 766 kaba kham duna ia ka jylla Meghalaya kaba kot haduh 989. Ka jingnujor ia ka jingdon ki khynnah kynthei shynrang ha ka shnong Borsora katkum ka khanasamari ka long 1200, kaba kham heh ia ka jylla Meghalaya kaba long 970.

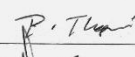
