Kane ka jaka ba thmu ban shim ka don kumba 3202.634 Sq. metres kaba hap hapoh ka jinglong trai jong 19 ngut ki trai jaka.

Ka jingthmu jong kane ka projek ka long ban lait na ka jingdheng kali kum ki kali heh ha ka surok bah NH 44(E) Shillong- Nongstoin- Tura; ban kham pynsuk ban pynsted iaka leit ka wan jong ki briew bad ki mar ki mata; bad ban ai ka lynti ia id kaba biang ban pyniasoh bad kiwei kiwei ki thain kiba don ha baroh sawdong kane ka Distrik bad ha Shillong.

Ka jylla Meghalaya ka don 6 tylli ki surok bah National Highways, kine kidei ka NH-44 bad NH-44 (Extn.), NH-40 bad 40 (Extn.), NH-51, NH-62, NH-127B bad ka Shillong Bye Pass kaba don ka jingjrong lynter kumba 1115.347 Km, ha kaba 900.662 Km na kane ka surok la peit bad pyniaid da ka tnad P.W.D. bad 214.685 Km pat la peit bad pyniaid da ka N.H.A.I.



Ka jingdon ki kynthei bad shynrang ka dei 874 ka kham duna ban ia ka Meghalaya state kaba long 989. Ka jingdon ki khyllung kynthei bad shynrang kat kum ka census ka long 622, kham duna ban ia ka jing don ha ka jylla (Meghalaya) kaba long 970. Ka jingnang jingstad ka lah kham kiew ha kane ka shnong haba ia nujor bad ka Meghalaya. Ha u 2011 ka jingnang jingstad ha ka shnong Shyrwang ka lah kot haduh 98.88% haba ia nujor bad ka Meghalaya kaba kot tang 74.43%. Ka jing don kiba lah nang lah stad ka long 98.32% jong ki shynrang bad ki kynthei 99.44%.

Ka shnong Langtor

Ka jing don ki khynnah kiba kyrta naduh 0-6 ki long 128 kaba dei 20.95% jong ka jingdon u paidbah ha kane ka shnong. Ka jingdon ki kynthei bad shynrang jong ka shnong Langtor ka long 869 kham duna ban ia ka Meghalaya kaba don kumba 989. Katkum ka census ka

jingdon ki khyllung kynthei bad shynrang ha Langtor ka long 829, kaba kham duna haba ia nujor ka jing don ha ka jylla Meghalaya kaba long 970. Ka jingnang jingstad ka lah kham kiew haba ia nujor bad ha ka jylla baroh kawei. Ha u 2011, ka jingnang jingstad jong ka shnong Langtor ka kot haduh 92.55% haba ia nujor bad ka Meghalaya kaba kot 74.43%.
