Ka Meghalaya Institute of Governance ka lah pynlong ia ka Social Impact Assessment study lane ka Jingbisharbniyah bad Pynshongdor ia ki Jingktah ha ka Imlang Sahlang haba iadei bad ka jingpynheh/pynbha ia ka surok bah NH-44 ha ka surok Shillong -Dawki ka ban long naduh ka Rilbong shaduh ka Mylliem Marbaniang. Kane ka projek ka don hapoh ka skim “North East Road Network Connectivity Project Phase I” bad ha ka jingbei tyngka jong ka Japan International Cooperation Agency (JICA). Ka jingthmu jong kane ka long ban wanrah ia ka surok kaba bha bad janai hapoh ka thain shatei lam mihngi, bad ban kham pynkh lain ka jingiadei hapoh kane ka thain bad kumjuh ruh ban kyntiew ia ka ioh ka kot ha ka thain hi baroh kawei.

Ki paidbah ki ioh jingmyntoi na kane ka projek namar ba kan pynduna ia ka jingdheng kali ha kane ka surok bad kane ka surok ka long ka surok kaba kongsan kaba pynia snoh bad kiwei pat ki ri. Kumta, donkam ruh ban peit ia ka jingiaidbeit iaid ryntih ki kali, ka jingshgain ki nong pyndonkam ia ka surok khnang ba kane ka projek kan long kaba seisoh.

Ka jingheh jong ka jaka baroh ka ban shah shim ka long haduh 275645sq.m lane kumba 68.11 akar bad kan iaid lyngba na Rilbong, 3 Mer, 5 Mer, Baniun bad na Mylliem Marbaniang kiba hap ha East Khasi Hills Distrik. Kine ki shnong baroh ki hap hapoh ka Mylliem C&RD Blok. La don haduh kumba 29 tylli ki longing kiba don bynta ha kane ka projek. Nalor ka jinglong trai ia ki jaka da ki riew shimet, la long trai ruh da ki tnad sorkar kiba kynthup ia ka Indian Army, Forest Dept., Agriculture Dept., Animal Husbandry and Veterinary Dept. Shillong Geophysical Research Centre, Pomlum Public Health Centre bad ka jaka pule phadar lane ka Don Bosco Sunny Side Novitiate.

Ki don katto katne ki jingtei (ki iingsah bad ki dukan) kiban shah ktah na kane ka jingshim jaka. Ka don ruh kawei ka parmau/par shyiap ha ka jaka ba thmu ban shim. Ka surok ba thmu ban shna thymmai kan iaid beit na ka surok rim, lait noh tang ha ki jaka kiba ka hap ban iaid lait kata ha ka shnong Laimer bad ha ka Lad 7 Mer. Ka surok Laimer Baypass kan iaid lyngba na ka khlaw jong ka Upper Shillong Protected Forests bad na ka Shillong Geophysical Research Centre. Ka surok Ritmawniew Bypass pat, kan kiar noh ia ka shnong 7 Mer hynrei kan iaid noh na ka surok Shillong-Nongstoin bad kan khun noh shaphang ka diang na Pomlum PHC ban rung sha ka shnong Baniun. Kan iaid lyngba ka shnong Baniun haduh ban da poi ha ka shnong Mylliem Marbaniang.

Ha ka por ba juripbniah, la dep ban ia syllok bad 22 ngut ki nongiashim bynta da kaba pyndonkam ia ki jingkylli kiba kham bniah kiba don ka jubab “hooid” ne “em” bad kiba hap

ban batai shai ia la ka jingsngew. Kumjuh ruh lah dep ban ia kren bad u rangbah shnong jong ka shnong Baniun bad ka shnong Mylliem bad kumjuh ruh bad ki tnad bapher bapher na Agriculture Dept., na Animal Husbandry and Veterinary Dept., na Shillong Geophysical Research Centre bad na ka Forest Dept. La ia syllok bad u nongmih khmat na ka Pomlum PHC kham hadien. Na kine ki jingiaphylliew jingmut, la ai jingmut ia ka kynhun wadbniah ban wanrah ia ki lad jingiarap kiba kynthup ia ki jingiada na ka jingtheh khydew kulmar sha ki jaka rep kiba don sha them bad ki jingiada ia ki tyllong um. Kiwei pat ki jingmut ki long ha kaba iadei bad ka jingkiar ia ka madan ialehkai kaba don ha Baniun bad kumjuh ruh ban jurip biang ia ka jaka ha ka jingiadon lang ki trai jaka bad u rangbah shnong. Ka tnad Agriculure ka kwah ban don ka jingsiew kyliang ia ki jingtei baroh kiban shah pynduh noh bad ki la pypaw shuh shuh ba dei ban iada ia ki dieng kiba la don kumba 100 snem tam eiei. Ka tnad Animal Husbandry and Veterinary Dept pat ka kwah ban pynneh pynsah ia ka jinglong khuid jingsuba ka jaka jong kane ka tnad treikam. Ka ophis SGRC pat, ka la kyrapad ban pyniaid lynti ia ka surok nawei khnang ban ym pynthut ia ka jingtrei kam jong kane ka ophis. Ka Pomlum PHC pat ka pypaw ba kane ka jingshim jaka kan pynduna noh ia ka jaka jong kane ka ophis bad kan ktah ia ka jaka sam bording namar ba uwei u transformer u don hajan ka kynroh jong kane ka ophis.



La pynbiang ia ka Social Impact Management Plan(SIMP) lane ka Jingthaw Buit halor kumno ban iarap/pynduna ia ki Jingktah ha ka Imlang Sahlang ha kaba iadei bad kane ka projek bad kane ka rukom thawbuit kan wanrah ki lad jingiada ia ki jingdon jingem kiba don ha ki jaka ba thmu ban shim, kumjuh ruh halor ka jingsiew ia ka jingduhnoh ia ki iing ki sem bad ki dukan, bad kiwei kiwei ki lad jingiarap.

Bynta - I: Jingbatai Bniah Halor ka Projek

Ka Thymmei halor ka Projek

Ka jylla Meghalaya ka long ka jaka lum, bad kam don da kiwei pat ki lad ban pyniasnoh bad kiwei pat ki jylla lait na ka surok. Wat la ki surok ha kane ka jylla ki long kiba biang, hynrei ki don pat ki khep ba kine ki surok kim pat da iar kat haduh ban da pyndap pynbiang ia ka jingdonkam jong u paidbah.

Ka surok ka long kaba donkam tam ha kaba iadei bad ka roi ka par bad kumjuh ruh ka ai jingshakri ia ki paidbah baroh. Ka surok ka long ruh kaba donkam ban kyntiew ia ka ioh ka kot ha ka imlang sahlang bad ka pynduh noh ia ka jing shah ieh khunswet jong ki shnong sha nongkyndong. Ka jingdon jong ki surok kiba biang kan long kum u budlum ban kyntiew ia ka ioh ka kot, ka roi ka par ha ka imlang sahlang, bad kan pynurlong ruh ia baroh ki jingdawa na ka bynta ka iaid ka ieng jong ki briew bad ka kit ka bah ia ki mar ki mata. Ka jingioh ban

pyniasoh ia ki surok bah kan wanrah shibun ki jingmyntoi ia ki bries namar ba kham bun ki kam shimet, ki karkhana, ki kam rep ki donkam ia ka surok kaba paka. Kane ka bynta jong ka NH 40 ka long ka surok kaba donkam bha namar ba ka pyniasnoh ia ka jylla Meghalaya bad ki jylla ba marjan bad kumjuh bad ka ri Bangladesh. Ka jingpynheh bad pyniar ia ka surok ka long ruh kaba donkam shibun khnang ban kyntiew ia ki kam khaii pateng, ban pyniasnoh shuh shuh bad kiwei pat ki jylla, ka kit ka bah ia ki mar ki mata bad ka iarap ruh ban kyntiew ia ki kam jngohkai pyrthei ha kane ka jylla.

Ki don saw tylli ki surok bah National Highways kiba iaid lyngba ka jylla Meghalaya; kine ki long ka NH 40, NH 44, NH 51 bad NH 62 kiba don baroh haduh 1205.338 kms ka jingjrong lynter². Ka surok bah NH 40 ka sdang naduh Jorabat bad ka kut shaduh Tamabil (Dawki) ha ka khappud Indo-Bangla. kane ka surok ka jrong lynter haduh 162.661 kms³. Ia ka National Highway lah phiah ha ki 2 bynta, kawei kadei ka Guwahati-Shillong bad kawei pat kadei ka Shillong-Tamabil. Ia ka surok Guwahati-Shillong lah dep ban pynbha bad pyniar sha ka 4-lane bad shibynta na ka surok NH 40 naduh Barapani shaduh Tamabil ka dang long ka surok 2-lane bad ka hap hapoh ka jingpeit jong ka State Public Works Department. Kane ka surok ka long kaba dang bha. Naduh 82 kms haduh 161.62 km (kaba kynthup ruh ia ka jingtei ia ka jingkieng Dawki), ka jingpeit bad jingpynbha ia ka surok ka hap hapoh ka jingbei tyngka jong ka Japan International Cooperation Agency (JICA) khnang ban pynheh ia ka surok sha ka 2-lane bad kumjuh ha kaba iadei bad ka jingpynwandur ia ka surok.

Haba kren kyllum, kane ka projek ka thmu ban pyniar bad pynbha ia ka surok bah NH 40 na Rilborg sha Dawki. Kane ka jingwadbniah kaba mynta ka long thik tang naduh Rilborg kaba don ha Shillong shaduh ka shnong Mylliem Marbaniang bad kane ka hap ha ka song banyngkong lane ka Package 1 jong kane ka projek, bad ka jrong lynter haduh kumba 10.50 km.

Ki Jingioh myntoi jong ki paidbah na kane ka projek

Kumba ka long mynta, ka surok ka long kum u budlum kaba pyniasoh ym tang ia ki shnong baroh kiba don ha ka jylla Meghalaya hynrei ka pyniasoh ruh ia ka ri India bad ka ri Bangladesh. Kane ka surok ka poi shaduh ka shnong Dawki-Tamabil kaba long ka jaka rung bad jaka mih jong ka ri India sha ri Bangladesh. Ka don ka jingthmu ban pynbha ia kane ka surok khnang ban kham pynkhain ia ka khaii patang bad ban kyntiew ia kane ka thain baroh kawei. Ki don ki bynta hapoh surok kiba long khim bad ba wanrah shibun ka jingdheng ne jingkhapngiah kali ha kane ka thain. Watla ka surok ka long kaba dang bha, hynrei ka long kaba rit bad kaba kyllain bad kaba bun khondgdong bad ka lah ban wanrah shibun ki jingjia aksiden. Namar ba ka surok ka long kaba khim bad kaba rit bad ki kali ruh ki lah nang bun kiba iaid lyngba kane ka surok, kumta ka long kaba donkam ban pynheh ia ka surok kaba don mynta khnang ban pynduna ia ka jingkhapngiah ha ka surok NH 40.

Jingbatai shai shaphang ka Projek

Ka jingpynheh ia ka surok lyngba ka jingbei tyngka jong ka JICA ka long hapoh ka jingkhmih jong ka North East Road Network Connectivity Project. Kane ka projek kan pynkiew ruh sha ka 403 kms ia ki surok bah National Highways kiba don ha Meghalaya bad Mizoram; na kine baroh, haduh 52 kms kin don hapoh jylla Meghalaya. Ia kane ka projek yn pyntreikam ha ka financial year jong u snem 2017-18 bad ia ki kam ha kaba iadei bad ki jingshna surok la khmih lynti ban pyndep ha u snem 2021 bad halor ka jingpynbha ia ka surok pat la khmih lynti ban pyndep ha u snem 2025. Kane ka projek kan kyntiew ia ka imlang sahlang bad ia ka ioh ka kot jong kane ka thain bad kan pynbha ia ki surok kiba don hapoh ka jylla Meghalaya bad Mizoram bad kumjuh ruh kan kham pynbha ia ki lynti syngkien kiba pyniasnoh ia baroh ki jylla bad ki jaka khappud. Ka jingshna pyniar ia ka surok 2-lane ka hap hapoh ka skim “North East Road Network Connectivity Project Phase I” lyngba ka jingbei tyngka na ka Japan International Cooperation Agency (JICA)⁴. Ka jingthmu jong kane ka long ban pynbha ia ka surok kiba pyniasnoh bad ka thain shatei lam mihngi, ban pynkhlain ia ka jingiadei ha kane ka thain bad kumjuh ruh ban kyntiew ia ka ioh ka kot ha ka thain hi baroh kawei.

Don ki bynta jong ka surok kiba rit bad khapngiah bad don ki bynta kiba shu biang ka jingheh. Ka rud surok ka long kaba sniew bad ha katto katne ki jaka kam i long shuh ban iaid lynti. 

Indian Institute of Geomagnetism, is a premier Research Institute, under the Department of Science & Technology, Govt. of India. The Institute had established a Magnetic Observatory at Shillong, Wilton Hall Estate, Upper Shillong in 1973. The prime objective of setting up the magnetic observatory at Shillong is to monitor the geomagnetic field variations in the North East region of the country.

It was in January, 2016 that Indian Institute of Geomagnetism (IIG) has taken a new initiative by upgrading the Magnetic Observatory to the Shillong Geophysical Research Centre (SGRC) as one of its Regional Research Centre. The focus of research at this newly established centre at Shillong would be on deciphering the pre and co-seismic signatures in various atmospheric regions over the North-East India using a variety of observational techniques.

It may kindly be noted that, various sensitive geophysical instruments such as Fluxgate Magnetometer, Induction coil magnetometer, Overhauser Magnetometer, Seismometer, Radon monitoring system, GPS receivers and MT instruments are installed at this Centre. The instruments deployed at this Centre are intended to operate over a long term period to achieve the desired scientific objectives. One of its main task is to monitor the geomagnetic variations. **The choice of the site for the observatory is of utmost importance.** It is important that the observatory site be magnetically representative of its region, for both secular and short term variations. Moreover, instruments like Seismometer and MT instruments are continuously recording ground vibrations and requires minimum disturbance (free from vehicular movement) to record the smallest signatures of seismic activities. Similarly, other instruments like radon monitoring systems, GPS, AEFM etc. also require noise free environment to function properly. Considering the above reasons, the regional centre was established at the present site which is free from electromagnetic noise caused by cultural activities and vehicular movement so as to yield quality data for geophysical research.

Recently, it is learnt that Government of Meghalaya has notified for the land acquisition to construct 2-lane / 4-lane road from Shillong to Dawki, which also passes through our campus. It

is understood from the project plan that the road will pass through the back side of the campus of our Centre.


It is also to be mentioned here that the instruments room, namely absolute room, Induction coil Magnetometer sensor room, Variometer room (Fluxgate magnetometer) and Overhauser magnetometer, seismic vault are lying very close to the backside of the campus. Therefore, construction of the proposed road and subsequent construction activities and vehicle movements or any other developmental activities near these rooms will definitely corrupt and contaminate the data recorded from these instruments and will further add the artificial noises to the instruments. This contaminated data would adversely affect our scientific research.

In this regard, we have strong objection for your proposed 2-lane / 4-lane road from Shillong to Dawki passing through our campus at SGRC, Shillong.

It is therefore, requested, to kindly replan, shift / divert the alignment of proposed road farther away from the SGRC campus keeping in mind the importance of scientific research activities and the usefulness of scientific data obtained from SGRC dedicated to the North East region in particular and scientific communities in general.
