Ban pyntreikam ia ka bor ba la pynkup da ka Sub Section (1) jong ka Section 4 lyngba ka Right to Fair Compensation and Transparency, in Land Acquisition Rehabilitation and Resettlement Act, 2013 (No. 30 of 2013), ka Sorkar Meghalaya ka la pynbna ia ka Meghalaya Institute of Governance kum ka nongpynshongdor ban bishar bniah halor ki jingktah ia ka Imlang-Sahlang ha ka jylla baroh kawei (State Social Impact Assessment Unit).

## **Ka Pasoh**

La pynlong ia ka Social Impact Assessment study lane ka Jingbniah ia ki jingktah ha ka imlang sahlang da ka Meghalaya Institute of Governance ha kaba iadei bad ka jingshim jaka ba lah thmu ban shna pyniar bad pynbha ia ka surok bah NH-40 ha ka surok Shillong sha Dawki ka ban long naduh ka shnong Bakur shaduh ka shnong Tamabil. Kane ka bynta jong ka surok kaba la khot ka Package 4, kan iaid lyngba lai tylli ki shnong kiba don ha West Jaintia Hills Distrik ha Amlarem C&RD Blok. Ka jingshna pyniar ia ka surok hapoh ka Song basaw lane ka Package 4 la tip kum ka surok thymmai jong ka Dawki (Dawki re-alignment road).

Watla ka surok bah NH 40 ka long kaba dang bha hynrei ka long ka surok kaba khim, kaba khongwain bad kaba bun ki khongdong kiba wanrah jingeh ia ki kali kiba iaid lyngba kane ka surok. Kane ka projek ban pynheh surok ka hap hapoh ka skim “North East Road Network Connectivity Project Phase IV” lyngba ka jingbei tyngka (loan assistance) jong ka Japan International Cooperation Agency (JICA). Ka jingthmu jong kane ka projek ka long ban wanrah ia ka surok kaba bha bad janai ha ka thain shatei lam mihngi, bad ban kham pynkhlain ia ka jingiadei hapoh kane ka thain bad kumjuh ruh ban kyntiew ia ka ioh ka kot ha kane ka thain hi baroh kawei. Ka paidbah ki ioh jingmyntoi na kane ka projek namar ba kane ka surok ka long kum u budlum kaba pyniasnoh ym tang ia ki shnong kiba don ha ka jylla Meghalaya hynrei ka pyniasnoh ia ka ri India baroh kawei bad ka ri Bangladesh. Kane ka surok, watla ka long kaba dang bha hynrei ka long kaba khim palat bad kaba khongwain bad ka wanrah shibun ki jingjia aksiden. Shaphang ka diang (LHS) jong ka surok ka don ka riat kaba jrong bad shaphang ka mon pat (RHS) u don u lum. Don ki bynta jong ka surok kumba ka long mynta kiba khim bad don ki bynta kiba kham iar (single lane to intermediate lane). Ki rud surok ki long kiba sniew bha, bad don ki bynta ki bym long ban iaid. Shuh shuh, ha lynter kane ka surok, lah ban don ka jingtwa khyndew. Kumta ka long kaba donkam ban pynbha bad shna pyniar sha ar bynta ia kane ka surok.

U pud jong ka surok rim (EROW) hapdeng ka shnong Dawki bad ka shnong Tamabil ka long kaba sniew bad kaba bun ki thliew surok namar ba bun ki kali heh ba kit jingkit khia ki iaid na kane ka surok. Kane ka EROW ka kynthup ruh ia ka jingkieng Dawki kaba rim. Takadaw, la don ka jingtyrwa ban shna ia ka surok Dawki kaba thymmai (Dawki re-alignment road) ka ban sdang naduh ka shnong Pomshutia bad kan iaid lyngba ka shnong Wahkdait bad Umsyiem hapoh ka East Khasi Hills Distrik bad kane ka surok thymmai kan poi shaduh ka wah Umngot. Nangne pat, la tyrwa ban shna thymmai ia ka jingkieng Dawki

kaban jngai haduh 300 meter eiei kham shaneng wah na ka jingkieng rim bad kan iasnoh bad ka shnong Dawki kaba hap ha Wast Khasi Hills Distrik. Ka surok Dawki ban shna thymmai ka hap ha West Khasi Hills Distrik bad kan sdang naduh ka shnong Dawki, kan iaaid lyngba ka shnong Bakur haduh ka shnong Tamabil kaba long ka shnong ha kaba ka khappud jong ka Indo-Bangladesh ka sdang. Kane ka surok ka jrong linter haduh 2 km eiei. Ki jaka ki ban shah ktah na ka jingwan jong kane ka projek ki long naduh 69.600 km – 71.520 km.

Ka surok Dawki kaba thymmai kan iaaid lyngba ka Dawki Public Health Centre (PHC) kaba don ha ka shnong Bakur. Kan iaaid kham shathie haduh ba kan iasnoh bad ka surok bah NH 40(E) ha ka shnong Bakur. Na kane ka lad, ka surok kan bud beit ia ka surok NH 40 (E) haduh ba kan da poi ha ka dong Lumparing ha ka shnong Bakur. Kan iaaid lyngba kane ka dong kaba don ka jaka ba thmu ban shna ia ka jaka sahnggeh trok bad kan iaaid lyngba ruh na ka phyllaw jong ka Forest Beat Office. Kan iaaid lyngba ruh na ka jaka ba don ka wahduid kaba mih tang ha ka por lyiur bad ka iasnoh biang bad ka surok rim ha khmat ka Tamabil Petrol Pump bad nangne kan iaaid bad bud ia u pud surok rim haduh ban da poi ha khappud Indo-Bangladesh.

Ka jingheh jong ka jaka baroh kaba la thmu ban shim ka long haduh 81631.670 sq.m bad kane ka long haduh 20.17 acres kaba kynthup ia ki jaka kiba don sha ka diang bad sha ka mon jong ka surok kaba hap hapoh West Jaintia Hills Distrik, Meghalaya. Haduh 28 ngut ki briew kiba don jingiadei bad kane ka projek la ithuh da ka ophis jong ka Deputy Commissioner (Revenue), West Jaintia Hills Distrik, Jowai. Na kine baroh, 15 ngut kidei ki riwshimet kiba dei ki trai jaka, kawei kadei ka skul (St. Francis De’sales School, Bakur), 2 tylli ki jaka jong ka BSF (kawei ka Dawki, BOP bad kawei pat ka jaka jong ka BSF kaba don ha Tamabil), 3 tylli ki jaka sorkar (Dawki PHC, Forest Beat Office, bad ka jaka jong ka Customs) bad 7 tylli kidei ki jaka ki bym shim la tip ia ki trai. Nalor kine, ha ka Jingpynsngew Paidbah kaba la dep pynlong ha ka 5 tarik u Lber 2019 ha ka shnong Bakur, ka ophis MIG ka la ioh pdiang shuh shuh ia ka kyrteng jong ki trai jaka kiba jah kyrteng bad la bsuh lang ia kine ki kyrteng ha kane ka kaiphod<sup>1</sup>.

Kham bun ki jaka kiba lah ban shah ktah ki dei ki jaka rep bad ki jaka shong jaka sah. Tang khyndiat ngut ki trai jaka ki wan ban iashim bynta namar ba bun na ki trai jaka kim don lang ha ka por ba jurip ia ka jaka. Bun ki trai jaka kiba wan ban iashim bynta ha ka jingiasyllok ki kloiban ai ia ka jaka jong ki lait noh tang ki trai jaka na ka shnong Tamabil. Haduh 13 tylli ki jingtei shimet kiba kynthup ia ki iing sah bad ki dukan kin sa shah ktah na ka jingwan jong kane ka projek namar ba kine ki jingtei baroh kin sa shah pynpra lut ne tang khyndiat bad donkam ban pynkynriah ia ki shawei. Ki jingdon jingem jong ka shnong, ki jingtei bad ka phyllaw jong ka skul, ka ophis jong ka PHC, ka jaka jong ka BOP, ka Petrol pump bad ka jaka jong ka ophis Custom kaba don ha ka shnong Bakur kine baroh ki lah ban shah ktah baroh ne tang malu mala na ka jingwan jong kane ka projek.

La pynlong ia ka Jingpynsngew paidbah ha ka 5 tarik u Lber 2019, na ka bynta kane ka projek. Ha kane ka Jingpynsngew paidbah, ki nongshong shnong bad ki dkhot jong ka longing na ka shnong ka ban shah ktah, ki pynpaw ba kim don kano kano ka jingpyrshah halor kane ka projek, hynrei u rangbah shnong jong ka shnong Bakur u la kyrpad ban pynbha


bad pynheh ia ka surok Dawki kaba don mynta. La pynkreh na ka bynta kane ka projek ia ka Social Impact Management Plan lane ban thaw buit halor kumno ban iarap bad pynduna ia ki jingtah ha ka imlang sahlung khang ban wanrah ki lad jingiada ia ki jingdon jingem kiba don ha ka khyndew, ban iarap halor ka jingsiew ia ka jingduhnoh ia ki iing ki sem bad ki duakn, bad kiwei kiwei ki lad jingiarap. Ia kane kajuha la bsuhlang haba kut jong kane ka kaiphod.

# Bynta – I: Jingbatai Bniah Halor ka Projek

## Ka Thymmei halor ka Projek

Ka jylla Meghalaya ka long ka jaka lum, bad kam don da kiwei pat ki lad ban pyniasnoh bad kiwei pat ki jylla lait na ka surok. Wat la ki surok ha kane ka jylla ki long kiba biang, hynrei ki don pat ki khep ba kine ki surok kim pat da iar kat haduh ban da pyndap pynbiang ia ka jingdonkam jong u paidbah.


Map 1 Ka Road Map jong ka East Khasi Hills



Ka surok ka long kaba donkam tam ha kaba iadei bad ka roi ka par bad kumjuh ruh ka ai jingshakri ia ki paidbah baroh. Ka surok ka long ruh kaba donkam ban kyntiew ia ka ioh ka kot ha ka imlang sahlang bad ka pynduh noh ia ka jing shah ieh khunswet jong ki shnong sha nongkyndong. Ka jingdon jong ki surok kiba biang kan long kum u budlum ban kyntiew ia ka ioh ka kot, ka roi ka par ha ka imlang sahlang, bad kan pynurlong ruh ia baroh ki jingdawa na ka bynta ka iaidei ka ieng jong ki briew bad ka kit ka bah ia ki mar ki mata. Ka jingioh ban

pyniasoh ia ki surok bah kan wanrah shibun ki jingmyntoi ia ki briew namar ba kham bun ki kam shimet, ki karkhana, ki kam rep ki donkam ia ka surok kaba paka. Kane ka bynta jong ka NH 40 ka long ka surok kaba donkam bha namar ba ka pyniasnoh ia ka jylla Meghalaya bad ki jylla ba marjan bad kumjuh bad ka ri Bangladesh. Ka jingpynheh bad pyniar ia ka surok ka long ruh kaba donkam shibun khnang ban kyntiew ia ki kam khaii pateng, ban pyniasnoh shuh shuh bad kiwei pat ki jylla, ka kit ka bah ia ki mar ki mata bad ka iarap ruh ban kyntiew ia ki kam jngohkai pyrthei ha kane ka jylla.

Haba kren kyllum, kane ka projek ka thmu ban pyniar bad pynbha ia ka surok bah NH 40 na Rilbong shaduh Dawki, bad kane ka jingwadbniah kaba mynta ka long thik tang naduh ka Dawki haduh ka shnong Tamabil kaba hap hapoh ka Package 4 lane ka Song ba-saw jong kane ka projek. Ka surok bah NH 40 ka sdang naduh Jorabat bad ka kut shaduh Tamabil (Dawki) kaba don ha khappud Indo-Bangla bad kane ka surok ka jriong lynter haduh 162.661 kms<sup>3</sup>. Kane ka National Highway lah phiah ha ki 2 bynta, kawei kadei ka Guwahati-Shillong bad kawei pat kadei ka Shillong-Tamabil. Ia ka surok Guwahati-Shillong lah dep ban pynbha bad pyniar sha ka 4-lane. Shi bynta na ka surok bah NH 40 kata na Barapani sha Tamabil ka dang long ka surok 2-lane bad ka hap hapoh ka jingpeit jong ka tnad PWD jong ka jylla (State Public Works Department). Kane ka surok ka long kaba dang



Naduh 82 kms shaduh 161.62 km (kaba kynthup ruh ia ka jingtei ia ka jingkieng Dawki), ka jingpeit bad jingpynbha ia ka surok ka hap hapoh ka jingbei tyngka jong ka Japan International Cooperation Agency (JICA) khnang ban pynheh ia ka surok sha ka 2-lane bad kumjuh ha kaba iadei bad ka jingpynwandur ia ka surok.

Shaphang ka diang (Left Hand Side) jong ka surok, ka jaka ka long lum da ki maw bad shaphang ka mon pat (Right Hand Side) ka jaka ka long riat kaba poi sha ka wah Umngot. Don ruh shi bynta ki surok kiba don ki jaka ban ia khaii pateng hynrei ki long kiba khim bad mad shibun ka jingdheng ne jingkhapngiah kali namar ka jingbun ki kali tourist kiba iaaid ha kane ka surok.

Ka paidbah ki ioh jingmyntoi na kane ka projek namar ba kan pynduna ka jingdheng kali ha kane ka surok kaba ka long ka surok kaba pynia snoh bad ki bar ri Bangladesh. Ka jing donkam ban peit ia ka jingiaid beit iaaid ryntih ki kali, ka jingshgain ki nong iaaid bad ki nongshong kali khnang ba kane ka projek kan long kam.

Ia kane ka projek yn pyntreikam ha ka financial year jong u snem 2017-18 bad ia ki kam ha kaba iadei bad ki jingshna la khmih lynti ban pyndep

ha u snem 2021 bad ka jingpynbha ia ka surok pat la khmih lynti ban pyndep ha u snem 2025. Kane ka projek kan kyntiew ia ka imlang sahlng bad ka ioh ka kot jong ka thain bad pynbha ia ki surok kiba don hapoh ka jylla Meghalaya bad Mizoram bad kumjuh ruh kan kham pynbha ia ki lynti syngkien kiba pyniasnoh ia baroh ki jylla bad ki jaka khappud. Ka jingshna pyniar ia ka surok 2-lane ka hap hapoh ka skhim “North East Road Network Connectivity Project Phase I” lyngba ka jingbei tyngka na ka Japan International Cooperation Agency (JICA)<sup>4</sup>. Ka jingthmu jong kane ka long ban pynbha ia ka surok kiba pyniasnoh bad ka thain shatei lam mihngi, ban pynkhlain ia ka jingiadei ha kane ka thain bad kumjuh ruh ban kyntiew ia ka ioh ka kot ha ka thain hi baroh kawei.

ki jingtah ia ki jingtei kiba don hajan ka jaka jong ka projek ba thmu ban pyntreikam da ka Sorkar; kane ka long ym tang ha kaba ia dei bad ka mariang hynrei kumjuh ruh ha kaba ia dei bad ka imlang sahlang.

Kane ka kynhun ka lah dep ban leit jurip ia 2 tylli ki shnong bad haduh kumba 16 ngut ki briew lah dep ban ia syllok.
