Dated Shillong, the 8th May, 2024.

Whereas it appears to the Government of Meghalaya that a total of 1046.25 Sq.m. land is required at Dangar Village, Balat, in East Khasi Hills District, for public purpose, namely for construction of OCR Complex for SIB as per boundaries described in the Schedule below:

The Additional Deputy Commissioner (Revenue), East Khasi Hills District, is appointed as Administrator for the purpose of Rehabilitation and Resettlement of the affected families.


Therefore, it is notified that for the above said project located at Dangar village, Balat in East Khasi Hills District, a piece of land measuring 1046.25 Sq.m. more or less whose detail description is given in the schedule to this Notification, is under acquisition.

This Notification is made under the provisions of Sub-Section(1) read with Section 40 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act No. 30/2013) to all whom it may concern.

A plan of the land may be inspected in the office of Deputy Commissioner, East Khasi Hills District, on any working days. The appropriate government is pleased to authorize the Deputy Commissioner and his staffs to enter upon and survey land, take levels of any land, dig or bore in the sub-soil and do all other acts required for the proper execution of their work as provided and specified in Section 12 of the said Act.

Under Section 11 (4) of the Act, no person shall make any transaction or cause any transaction of land that is sale/purchase, specified in the Preliminary Notification or create any encumbrances on such land from the date of publication of such notification without prior approval of the District Collector.

This notification is made under the provision of Section 11 (1) read along with Section 40 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act No.30/2013).
