(Under Section 11(1) of the RFCTLARR Act, 2013)

Whereas it appears to the Government of Meghalaya that, total area of 270B-4K-0L Bighas or 362276.24 Sq.Mtrs is required at Bolsalgre under Banduraja A-king, South West Garo Hills for construction of Integrated Housing Complex as per boundaries in the statement attached.

Social Impact Assessment (SIA) Report and Social Impact Mitigation Plan (SIMP) vide No.RDA.40/2014/47 Dated Shillong the 1st June 2017 was published and circulated u/s 6(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.

Therefore, it is notified that for the above said project the Integrated Housing Complex at Bolsalgre under Banduraja A-king, South West Garo Hills a land measuring 270B-4K-0L Bighas or 362276.24 Sq.Mtrs whose detail description is given in the measurement attached to this Notification, under this acquisition.

This notification is made under the provision of Section 11(1) of Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act No.30/2013) to all whom it may concern.

A plan of the land may be inspected in the Office of the District Collector / Deputy Commissioner, South West Garo Hills, Ampati on any working day during the working hours.

The Government is pleased to authorize the District Collector / Deputy Commissioner, South West Garo Hills, Ampati and his staff to enter upon and survey the land, take levels of any land, dig or bore into the sub-soil & do all other acts required for proper execution of their work as provided and specified in section 12 of the said Act.

Under section 11(4) of the Act, no person shall make any transaction or cause any transaction of land i.e., sale / purchase etc., or create any encumbrances on such land from the date of publication of such notification without prior approval of the Collector.

Objection to the acquisition, if any, may be filed by the person interested within 60 (sixty) days from the date of publication of this notification as provided under section 15 of the Act before the District Collector.
