Preliminary Notification

(Under Section 11 (1) Read with Section 40 of the Act – 30/2013)

Dated Shillong, the 26th September, 2025.

Whereas it appears to the Government of India, Ministry of Home Affairs that a total of 21109 Sq.m./2.112 hectares is required from the Disputed A'kingland (Adugachol / Magupar) under West Garo Hills (BP.No.1115/7S to 1117/MP) for construction of Indo-Bangladesh Border Fencing (1.919 Kms Unfenced Area).

The Additional Deputy Commissioner (Revenue), West Garo Hills District, is appointed as Administrator for the purpose of Rehabilitation and Resettlement of the affected families.


Therefore, it is notified that for the above said project from the said A'kingland in West Garo Hills, a piece of land measuring more or less 21109 Sq.m. / 2.112 hectares whose detail description is given in schedule to this Notification, is under acquisition.

This Notification is made under the provisions of Section 11(1) read with Section 40 of the Act-30/2013 of The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act No. 30/2013) to all whom it may concern.

A plan of the land may be inspected in the office of Deputy Commissioner, West Garo Hills District, on any working days. The appropriate government is pleased to authorize the Deputy Commissioner and his staffs to enter upon and survey land, take levels of any land, dig or bore in the sub-soil and do all other acts required for the proper execution of their work as provided and specified in Section 12 of the said Act.

Under Section 11 (4) of the Act, no person shall make any transaction or cause any transaction of land that is sale/purchase, specified in the Preliminary Notification or create any encumbrances on such land from the date of publication of such notification without prior approval of the Deputy Commissioner.

This notification is made under the provision of Section 11 (1) read with Section 40 of the Act-30/2013 of The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act No.30/2013).


