

Therefore, declaration is made that the plot of land measuring more or less **929.620** Sq. Mtrs of standard measurement in the Village Byndihati, East Jaintia Hills District as per detail description below is under acquisition for the above said project and is required to be taken by the Government for public purposes:-

North: Village Land of Byndihati village.
East: Land of Smt. Santa Mary Shylla, Byndihati village.
South: Land of Shri Thomas Nongtdu, Byndihati.
West: National Highway.

This declaration is made Under Section 19 read along with Section 40 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013. There are no families to be resettled due to Land Acquisition.
